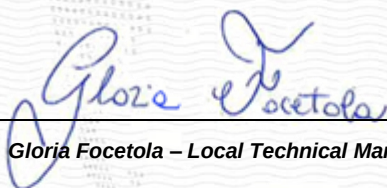

The verification was carried out by: Sebastiano Greco (TL), on 28 March 2024 (initial documental analysis) and on 10, 11, 17, 18 April 2024.

The analyzed products refer to the Vita[®] and Revolutionary[®] families. Five fabric classes have been identified, each representative of a range of grammages:

Class 1: < 120 g/m²

Class 2: 120 – 150 g/m²

Class 3: 150 – 170 g/m²

Class 4: 170 – 200 g/m²

Class 5: > 200 g/m²

The significant impact categories identified by the PCR (Product Category Rules) are the following: Climate Change, Resource Use, Fossil, Water Use. For all three categories, both characterized results and normalized and weighted results were calculated. The sum of the weighted results in the three significant categories makes up the Single Score, which was compared with the thresholds of the Performance Classes provided by the Regulation for the implementation of the national voluntary scheme for the evaluation and communication of the environmental footprint of products, called "Made Green in Italy":
